Paddling, whether in outrigger, SUP or surfski, is a considerable test of an individual's personal fitness, strength, coordination and endurance. Participation involves many risks, dangers and hazards, and poses a very real risk of injury to each and every participant and other non-participants nearing the activity. These risks cannot be eliminated, even with comprehensive planning and preparation. The risks, dangers and hazards include, but are not limited to, the following: weather and water conditions (including sudden and unexpected changes), equipment failure, drowning, hypothermia, collision with other objects, including rocks and other boats, and injury caused by other participants, which may include negligence, imprudence, lack of skill or error of judgment on the part of the other participants (all collectively referred to as "Risks").

To: Jericho Paddling Club, its directors, officers, members, agents, organizers, volunteers, representatives, sponsors, successors and assigns and the Jericho Sailing Centre (all collectively referred to as "Jericho"):

In consideration of being permitted to use Jericho Paddling Club equipment, and to participate in paddling events:

1. I hereby agree to abide by the rules and regulations of Jericho and its Directors, and any instructions given by Jericho.
2. I hereby acknowledge that Membership involves the Risks, and I freely accept and assume all risk of personal injury, death, property damage or loss resulting from any cause, including, but not limited to, the Risks.
3. For myself, members of my family, my heirs, executors, administrators, next of kin, successors and assigns, I hereby:
  - a. Waive, release and forever discharge any and all claims that I may now or in the future have against Jericho, or any one or more of their heirs, executors, administrators, next of kin, successors or assigns (the "Releases"), including any and all claims for personal injury, death, property damage or loss sustained by me, due to any cause whatsoever, including cause by any of them arising out of my participation in the paddling training, races or related events, together with any costs, including lawyers' fees, that may be incurred as a result of any such claims whether valid or not; and
  - b. Indemnify and hold harmless the Releases of each of them against any such claim that I or my guests or any one or more of my or their heirs, executors, administrators, next of kin, successors, or assigns may have or assert and against any costs, including lawyers' fees, with respect thereto.
4. I hereby acknowledge that I have sole responsibility for my personal possessions and athletic equipment during the paddling activities, races and related activities.
5. I hereby acknowledge that participation in paddling competition is potentially hazardous. Therefore, I hereby release the CANADIAN OUTRIGGER CANOE ASSOCIATION ("CORA"), its directors, officers, members, agents, organizers, volunteers, representatives, and sponsors, of any liability arising from loss, injury or death during events sponsored or sanctioned by CORA.
6. I hereby attest that I am able to swim and that I am in satisfactory physical condition for the physical exertion required in outrigger canoe racing.
